

MIKE JENNEY MURALS - CUSTOM ARTWORK CONTRACT

Bringing Your Vision to Life with Professionalism & Artistic Excellence

This contract is a formal agreement between Mike Jenney Murals (Artist) and Client for the creation of a custom artwork.

1. PROJECT SCOPE & AGREEMENT

The Artist will create a custom, hand-painted mural, airbrush design, sculpture, or decorative finish as agreed upon in writing.

- * Project Description: (Details of the artwork, location, dimensions, and any special requests will be outlined in the project brief.)
- * Materials & Techniques: (Description of paints, coatings, sealants, or other materials to be used.)
- * Estimated Completion Date: (Timeline based on project complexity and scheduling.)

2. PRICING & PAYMENT TERMS

Mural Pricing Structure:

Size of Mural | Estimated Cost

Over 50 sq. ft. | Starting at \$25 per sq. ft. (Final cost based on detail & complexity)

- * Design Fee: A non-refundable design fee of \$1,000 is required before the first sketch. This fee is applied towards the final project cost.
- * Minimum Project Fee: The minimum commission for any project is \$500.
- * Travel Fee: Projects outside Pinellas County will incur a travel surcharge (to be determined based on location).

Payment Schedule:

- * Deposit: A 50% non-refundable deposit is required to secure the booking.
- * Final Payment: The remaining balance is due immediately upon project completion.
- * Additional Costs: Any design changes or additions requested after project approval may result in an additional charge.

3. DESIGN PROCESS & REVISIONS

- * Concept Development: The Artist will provide initial sketches based on client input.

- * Revisions: The design fee includes up to two revisions to the initial concept. Any additional revisions may be charged.
- * Final Approval: The Client must approve the final design before painting begins.

4. PROJECT EXECUTION & SITE PREPARATION

- Client Responsibilities:
 - Ensure the work area is clear, dry, and accessible for the duration of the project.
 - If applicable, provide scaffolding or lifts for murals requiring elevated work.
- Artist's Commitment:
 - Work will be completed using high-quality materials and professional techniques to ensure longevity.
 - Protective coatings will be applied where necessary for durability and fade resistance.

5. CANCELLATIONS, RESCHEDULING & REFUNDS

- * Cancellation Policy:
 - If the Client cancels after the deposit is paid, the deposit is non-refundable.
 - If the Artist cancels due to an emergency, a full refund will be issued for any uncompleted work.

6. ARTISTIC RIGHTS & OWNERSHIP

- * Copyright & Usage Rights:
 - The Artist retains full copyright to the artwork and may use images for portfolio, marketing, and promotional purposes.
 - The Client may display the artwork for personal or business use but may not reproduce or modify it without written permission.

7. LIABILITY & SATISFACTION GUARANTEE

- * Quality Assurance:
 - The Artist guarantees high-quality workmanship and offers minor touch-ups within 30 days of completion.
